1. Passport

- ☐ Passport issued within the last **10 years**
 - ☐ Valid for **at least 3 months after course completion**
 - ☐ Minimum **2 blank pages**

2. Visa Application Form

- ☐ Completed and signed visa application form
 - ☐ Signed by **both parents** (if applicant is a minor)

3. Covering Letter / Statement of Purpose (Max 1 Page)

- ☐ Reason for choosing the course
 - ☐ Reason for choosing the Italian institution
 - ☐ Explanation of financial support
 - ☐ Scholarship details (if applicable)
 - ☐ Intended accommodation in Italy

4. Proof of Admission

- ☐ Admission letter from Italian Higher Education Institution
 - ☐ **University Pre-Enrolment Summary** (if required)
 - ☐ Proof of **enrolment fee payment**
 - ☐ Fee payment visible in bank statements

5. Proof of Previous Education

- ☐ Final Degree / School Certificate (attested & apostilled)
 - ☐ Academic Transcripts / Marksheets (attested & apostilled)
 - ☐ One of the following (if required by institution):
 - ☐ Declaration of Value (DOV)
 - ☐ CIMEA Certificate
 - ☐ Proof of DOV application (if not issued yet)
 - ☐ Updated Curriculum Vitae (CV)

6. Proof of Financial Means

- ☐ Minimum funds: **€6,079.45 per year** or **€506.62 per month**
- ☐ **6 months original bank statement** of applicant
- ☐ Bank statement stamped & signed by branch manager
- ☐ Proof of income (any applicable):
 - ☐ ITR (last 3 years)
 - ☐ Employment / Business proof
 - ☐ DEMAT statements
 - ☐ Family income certificate
 - ☐ Education loan (amount visible in bank statement)

If Sponsored (Parents / Legal Guardians only)

- ☐ Sponsor's 6 months original bank statement
 - ☐ Sponsorship letter
 - ☐ Sponsor's ID proof
 - ☐ Sponsor's income documents (ITR, employment, DEMAT, etc.)

7. Overseas Medical Insurance

- ☐ Minimum coverage: **€30,000**
 - ☐ Valid for **first 6 months in Italy**
 - ☐ Includes **repatriation clause**

8. Air Travel Proof

- ☐ Round-trip flight reservation (PNR verified)
- OR**
- ☐ Additional **€2,000 financial proof** over minimum requirement

9. Proof of Accommodation

- ☐ Confirmed accommodation in Italy
- ☐ Valid for **minimum 30 days**
